ARTICLES OF INCORPORATION
OF

GREATER HOUSTON LOCKSMITHS ASSOCIATION, INC.

We, the undersigned natural persons of the age of twenty-one (21) years of age or more, at least two of whom are citizens of the State of Texas, acting as incorporators of a corporation under the Texas Nonprofit Corporation Act, adopt the following Articles of Incorporation for such Corporation:

1. The name of the Corporation is GREATER HOUSTON LOCKSMITH ASSOCIATION, INC.
2. The period of its duration is perpetual.
3. The purposes for which the Corporation is organized are:
 - a. To promote the practice of quality locksmithing throughout the Houston, Harris County, Texas area, and to encourage the betterment of such practice by training, education and the establishment and pronulgation of high standards of professional competence.
4. The members of the corporation shall be designated in the by-laws of the Corporation.
5. The manner in which the Directors are to be elected or appointed is by vote of a majority of the membership.
6. The address of the initial registered office of the Corporation is 1945 Restrige, Houston, Texas, 77055, and the name of its initial registered agent at such address is JERRY McPHATE.
7. The number of directors constituting the initial Board of Directors of the Corporation is six (6), and the
